The Managing Trustee shall hold office for life. In the event of vacancy arising in the Office of the Managing Trustee the Joint Managing Trustee shall assume the office of the Managing Trustee. If owing to illness or any other reasons the Managing Trustee is unable to discharge his function, also the Joint Managing Trustee shall assume the office as Managing Trustee for the purpose of this clause and shall be eligible to exercise all the powers of the Managing Trustee.

The Joint Managing Trustee shall also hold office for life. In the event of a vacancy arising in the office of the Joint Managing Trustee, the then existing Trustees may nominate one among them as Joint Managing Trustee and such elected Joint Managing Trustee shall be eligible to exercise all the powers of the Joint Managing Trustee.

The above said procedure in regard to the nomination and functioning of the Managing Trustee and the Joint Managing Trustee shall apply to the persons who succeed to hold these offices.

The Trustees except the Managing Trustee and the Joint Managing Trustee shall hold office for a period of two years from the date of such nomination and shall be eligible for renomination.

Any vacancy arising in the category of nominated Trustees at the end of the term or otherwise shall be filled up by the Managing Trustee and Joint Managing Trustee with mutual consent.

In the event of a vacancy arising in the Office of a nominated trustee due to death, insolvency, resignation etc., the Managing Trustee and Joint Managing Trustee may appoint a person to fill his vacancy and the person so appointed shall hold office for the remaining terms for which the original incumbent would have been eligible.

While nominating Trustees for the J.G.V.V. Trust due regard shall be taken of the suitability and aptitude of the persons in pursuing the ideology and the objectives of the Trust.

The Managing Trustee shall preside over all the meetings of the Board of Trustees. In the absence of Managing Trustee the Joint Managing Trustee shall preside over all the meetings and in the absence of both the other trustees present in the meeting shall select one among themselves to preside over the meeting of the Board of Trustees.

Resolutions and decisions of the Board of Trustees shall be on the basis of the majority of votes by Trustees present with each trustee having one vote. In the event of a tie in the tally of votes the person presiding over the meeting shall have an additional casting vote.

In case of any vacancy in the Trust Board arising by death or resignation or otherwise the remaining Trustees will have full powers to represent the Trust Board.

The Trustees of this Trust will be at liberty to receive and to accept gifts, any voluntary contributions in cash or kind, movable and immovable properties on behalf of the Trust, from any person or persons and also the movable and immovable properties earmarked or given during the life time of the donor or after his death by legacy and as per his/her will can be acquired and to be formed property of the Trust. The immovable properties so received should be transferred in the name of the Trust as per the law in force. The Trustees are hereby authorised and empowered to execute the necessary agreement and deeds etc., The Trustees are hereby authorised and empowered to lease the immovable properties and let it out exclusively for the purpose and the benefit of the Trust.

The Trustees may frame rules by a resolution for the administration and management of the Trust, or for carrying out the objects of the Trust, and such resolutions and rules framed amended, altered or substituted shall have the same force as if they have been incorporated in the original Trust hereby created but not repugnant to the objects of the Trust.

The Trustee shall have power to invest the Trust Funds in any form of investment or change the form of investment where they are satisfied that such investment will yield a reasonable income or where it is deemed expedient or necessary for carrying out the objects of the Trust.

Funds of the Trust shall be deposited in any one or more Nationalised Banks or with any other public sector Institutions etc., as permissible under the Income Tax Act from time to time.

The Bank/Banks accounts of the Trust shall be operated by such persons as are authorised by a resolution by the Board of Trustees for this purpose.

The Trust shall maintain the accounts regularly and keep proper books of accounts of the income and expenditure of the Trust, which shall be closed on 31st of March every year and the account shall be audited by a qualified Auditor every year.

The Board of Trustees shall have powers to raise donations and augment resources of revenue of the school. The funds of the schools shall be utilised by the Board in accordance with the objectives of the Trust.

The Board of the Trustees shall meet once in THREE MONTHS to conduct the affairs of the Trust.
